Attached is a list of the year 2012 meetings of the Variance Review and Advisory Committee for Onsite Sewage Treatment and Disposal Systems.

Eight copies (or an original and seven copies) of a complete variance application package must be received in the Onsite Sewage Program office no later than the 15th of the month in order for the application to be included on the agenda for the following month's meeting. If the 15th falls on a legal holiday or weekend, applications will be accepted until the close of business the next day following the holiday or weekend.

Information submitted should be comprehensive, clear and concise since the variance committee members have no knowledge of the situation involved in the variance request beyond what is contained in the application. Applications that are incomplete may be returned, tabled or denied. Instructions for completing and assembling a variance application package are printed on the back of the variance application form. Please make sure that any forms you provide to an applicant include the instructions. The variance application form (DH 4057, 8/2009) is available on the DOH internet and intranet websites.
